On the first line of each item you first see the 'tullid' number and then a text indicating the type of declaration or customs decision.

In this example 'Diverse avgifter' means 'Miscellaneous fees and charges', and 'Komplet. tulldeklaration' means 'Supplementary customs declaration'.

Tullid (Customs identification number) is a unique identification number given to each declaration.

This line shows the Customs office where the declaration was processed and a phone number which you can call if you have any questions regarding the bill or the customs decision.

If you are calling from abroad, add the national code +46 and omit the first digit '0' of the telephone number.
