Detta slutprov görs i 2 steg.

CWDS, standarddeklaration med efterföljande ändring av standarddeklaration, CWDC

Steg 1

Meddelande: CWDS standarddeklaration, hänförande till tullagerförfarandet, allmänt tullager.

Förutsättning: En standarddeklaration CWDS, (allmänt tullager), utan fel sänds in till Tullverket. Ärendet består av en varupost.

Detta scenario beskriver en standarddeklaration för hänförande till tullagerförfarandet för ett allmänt lager där uppgiftslämnaren agerar ombud. Ombudet skickar in tullagerdeklarationen elektroniskt och får positiv kvittens och ett tullbeslut som visar att varorna frigjorts till tullagerförfarandet, steg 1.

Därefter skickas en begäran om ändring av en Standardtulldeklaration för hänförande till tullagerförfarande efter att varorna har frigjorts till förfarandet. Deklaranten skickar in ändringen av tullagerdeklarationen elektroniskt och får positiv kvittens och ett tullbeslut som visar att Tullverket tillåter ändringen, se steg 2 nedan.

Resultat: CWDS sänds in av ombudet. Tullverket returnerar en mottagningskvittens, TLKVT, med statuskod TEM, som visar att tulldeklarationen är tekniskt mottagen. Tullverket validerar deklarationens innehåll och ytterligare ett svarsmeddelande KVT med statuskod ING och GOD genereras tillbaka till ombudet innehållande ärendets MRN (Master Reference Number), som referens anges LRN (Local Reference Number).

När deklarationen är granskad och godkänd av Tullverket skickas ett meddelande RES med statuskod FRI, som referenser anges LRN och MRN.

Dessutom skickas meddelande CWDF som innehåller alla uppgifter från den frigjorda deklarationen. Ombudets system ska kvittera både meddelande RES och CWDF

6. Skicka tekniska kvittenser på frigörandebeslut (FRI) och Frigjord tulldeklaration (CWDF).
