## **Tullager Testfall 6**

Detta testfall görs i 3 steg.

CWDP, standarddeklaration i förväg, med efterföljande rättning, CWDR och därefter *anmälan om varors ankomst* (aktivering av deklaration), CWDA

### **Steg 1**

**Meddelande:** CWDP, standarddeklaration i förväg.

**Förutsättning:** En standarddeklaration inlämnad i förväg CWDP, (privat tullager), utan fel sänds in till Tullverket. Ärendet består av 1 varupost.

Detta scenario beskriver en standarddeklaration inlämnad i förväg för ett privat lager där uppgiftslämnaren agerar ombud. Deklarantens godslokalkod för det privata lagret anges.

I detta testfall är det samma aktör som skickat in deklarationen som anmäler varors ankomst.

I en deklaration i förväg (CWDP) kan följande fält utelämnas, Godsets förvaringsplats och Tidigare handling. Om inte Tidigare handling anges i deklarationen i förväg så måste en rättning (CWDR) med dessa uppgifter skickas in innan deklarationen kan aktiveras med en CWDA.

*I detta testfall utelämnas uppgift om Tidigare handling i den CWDP som skickas in i steg 1.*

**Resultat:** CWDP sänds in av ombudet. Tullverket returnerar en mottagningskvittens, TLKVT, med statuskod TEM, som visar att tulldeklarationen är tekniskt mottagen. Tullverket validerar deklarationens innehåll och ytterligare ett svarsmeddelande KVT med statuskod ING genereras tillbaka till operatören, som referens anges LRN (Local Reference Number)
