#### Information about Tariff File Distribution

You wish to get access to Tariff File Distribution. Swedish Customs offers companies and others a solution called Tariff File Distribution (TF). The service is free of charge and gives the users the possibility to keep their systems updated with Tariff data on a daily basis.

Briefly, you open <a href="https://distr.tullverket.se/tulltaxan/">https://distr.tullverket.se/tulltaxan/</a> in a browser to get to the files. The server contains complete distribution files with all Tariff data, but also daily difference files only containing the changes from the previous update. Accordingly, you must first load the total files and then the daily difference files. If you have no need for daily updates, the total files can be used for a one time data load.

The files are PGP signed and encrypted and zipped.

They are available in XML-format. You will need to develop a solution to automatically download files by HTTPS and unzip them by ZIP program and decrypt them by PGP, learn to interpret the contents of the files, and select the information relevant to your own system. No further support will be provided by Swedish Customs. If errors occur, we recommend to start all over by loading the total files.

# Access to Tariff files from Swedish Customs (TF, Tariff File Distribution).

Updated Tariff files are transferred as specified on a regular basis (every weekday at approximately 11.00 pm).

#### How to open files

To open and use files, you first need to remove the seal. Thereafter the files have to be unzipped. For more information, please read on the website specified above.

If you intend to use the files and would like continuous information about the service, such as changes, operational issues, etc., and access to operational status

updates, you can subscribe on the page "<u>Prenumerera på it-drifinformation</u>". Choose "Driftinformation Tulltaxan" (available only in Swedish).

If you choose to use daily updated files, the recommendation is to download the total files regularly. In the event of any errors in incremental files, it's recommended to restart with latest version of total files. No further support will be provided by Swedish Customs regarding file distribution, but is happy to receive incidents for the knowledge of events of errors.

## Other things

Tariff File Distribution service requires developing a technical solution, if you have less need for specific Tariff data, the following solutions might be another option.

### Commodity codes and descriptions

If you are only interested in commodity codes and descriptions and do not require daily updates, there is a simpler solution than TF. By downloading an Excel document via the link "Commodity codes in Excel," which you can find under the menu "More information – Links" in the Customs Tariff search system (http://tulltaxan.tullverket.se), you can obtain that information.

#### **Exchange rates**

It is possible to retrieve exchange rates as a file via the Swedish Customs Tariff search system: https://tulltaxan.tullverket.se/

Go to the menu "<u>Calculate customs duties – Exchange rates</u>", search for all currencies or a specific currency code, and click the "Export" button, and an Excel document will be generated. Click "Export XML" to download XML-files.
